NEUBERGER BERMAN INVESTMENT FUNDS PLC (THE "COMPANY")

We are writing to you in your capacity as a Shareholder in the Company. The purpose of this circular is to notify you of a change to the maximum remuneration payable to the chairperson of the Company, which will be reflected in a revised Prospectus for the Company, due to be noted by the Central Bank on or around 2 March 2020 (the "Effective Date"), subject to the approval of the Central Bank. This change is in addition to the changes which were set out in the previous circulars issued in relation to the sub-funds of the Company on 20 December 2019 (the "Previous Circulars"). Unless otherwise indicated, all capitalised terms shall have the same meaning as otherwise described in the Company's Prospectus dated 2 September 2019.

Changes to the maximum remuneration payable to the chairperson

By way of background, the Central Bank now requires an independent director of the Company to undertake an organisational effectiveness role, which is designed to ensure that the Company is organised and resourced in an appropriate manner on an on-going basis. This role is in addition to their day-to-day responsibilities stemming from their role as a director of the Company and, in this case, the role of acting as chairperson of the Company. In light of the increased responsibilities and duties stemming from the adoption of this organisational effectiveness role by the chairperson of the Company, the maximum annual remuneration payable to the chairperson of the Company has increased by $\in 5,000$ (i.e. from $\in 80,000$ to $\in 85,000$).

The change as discussed in this circular will be reflected in the same revised Prospectus as mentioned in the Previous Circulars in due course. Once noted by the Central Bank, the revised Prospectus may be inspected free of charge at the offices of the Hong Kong Representative at 20th Floor, Jardine House, 1 Connaught Place, Central, Hong Kong, during normal business hours on any Hong Kong business day.
