This notice is not for tax reporting purposes and is being provided only for informational purposes to comply with the requirements of Section 19(a) of the Investment Company Act of 1940, as amended, which requires notice to shareholders if the payment of any distribution is made from any source other than net investment income. After definitive information is available, the shareholders of the Fund will receive a Form 1099-DIV specifying how the distributions paid by the Fund during the relevant calendar year have been characterized for federal income tax purposes.
