## FUND OBJECTIVE

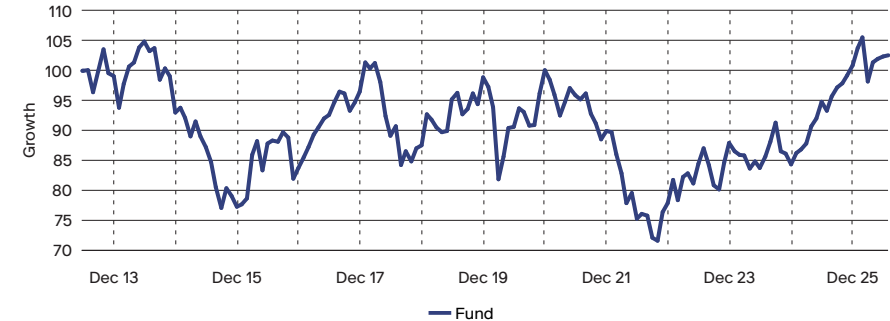

## RISK CONSIDERATIONS
