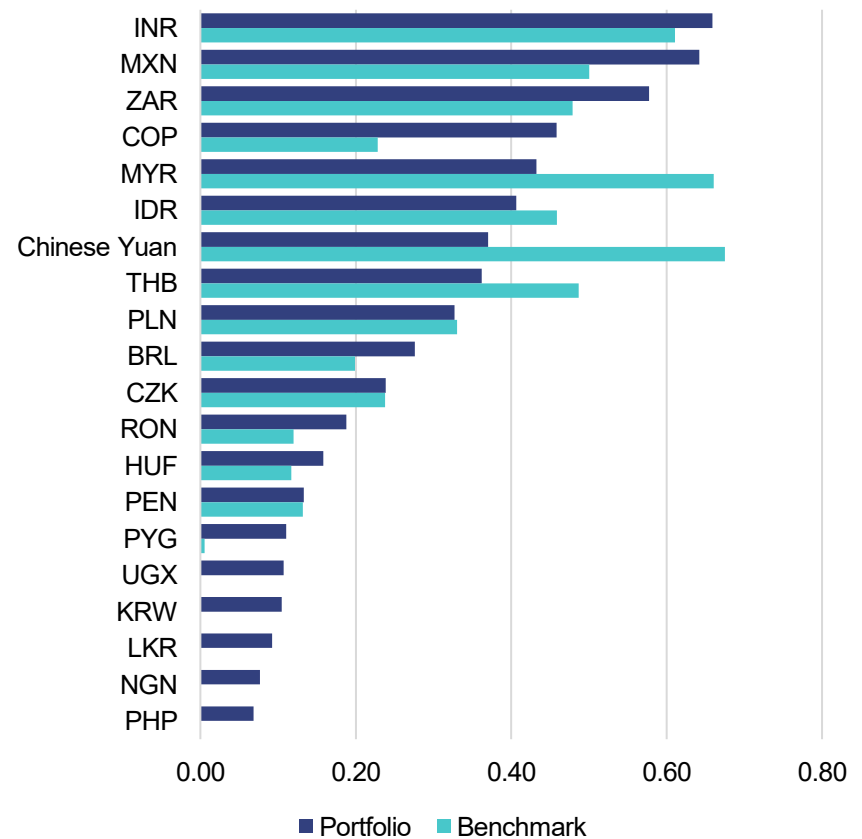

Weighted Interest Duration per Country (yrs) – Top 20



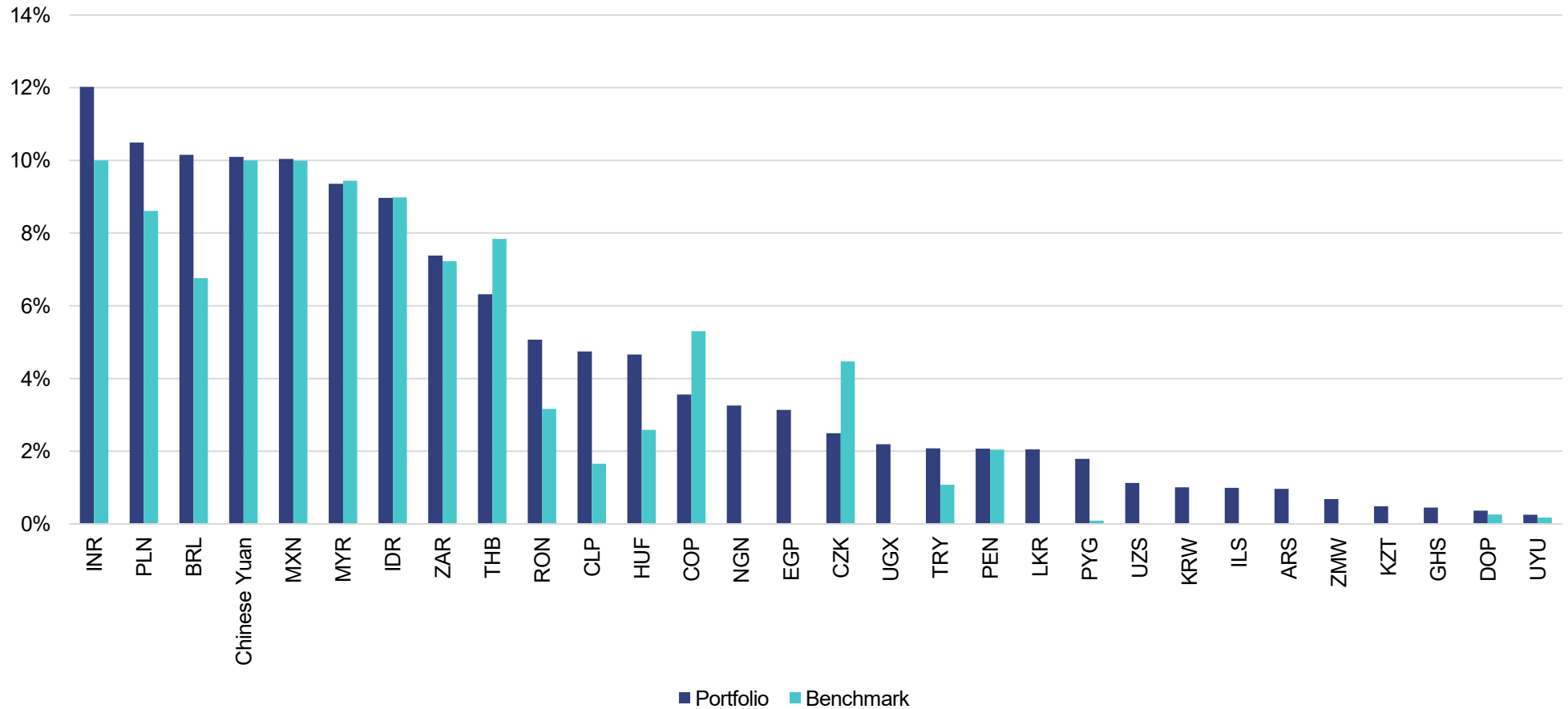

Risk Considerations

Type	Description
