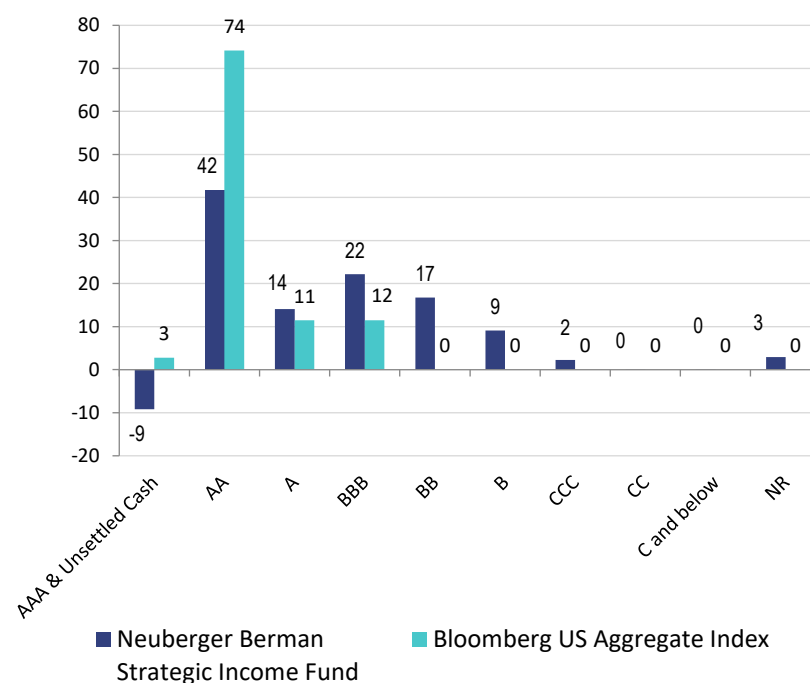

CREDIT EXPOSURE (%)



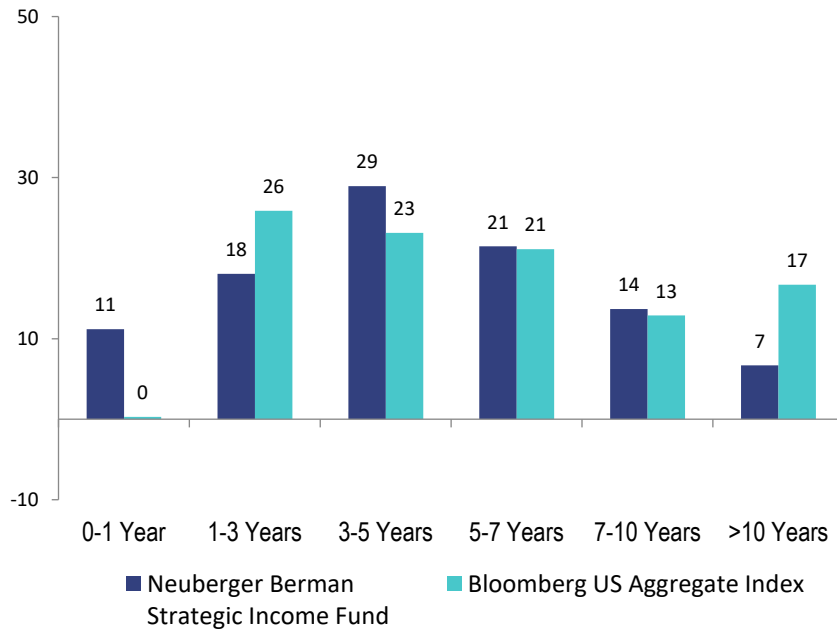
