- Sound future business prospects.

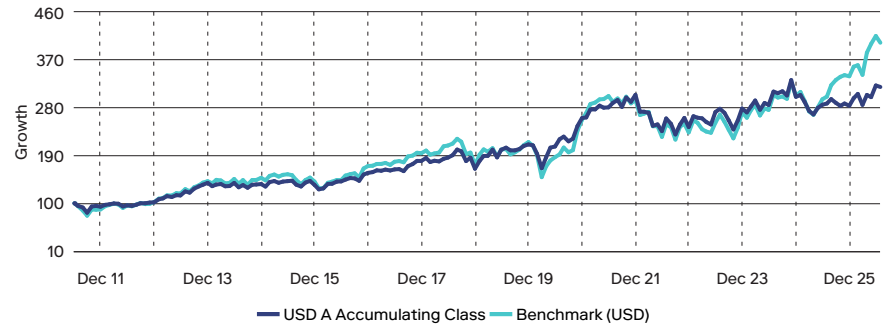
