

Neuberger Global Equity Megatrends Fund

Important Notes

1. The Fund invests primarily in equity securities that are (1) listed or traded principally on recognized markets globally (which may include emerging market countries) and (2) issued by companies across all market capitalizations and industrial sectors.
2. The Fund is subject to concentration risk as the fund's investment are concentrated in companies that offer exposure to the secular themes identified by the Sub-Investment Managers.
3. Investments in small-capitalisation / mid-capitalisation companies are subject to higher liquidity and price volatility risks. 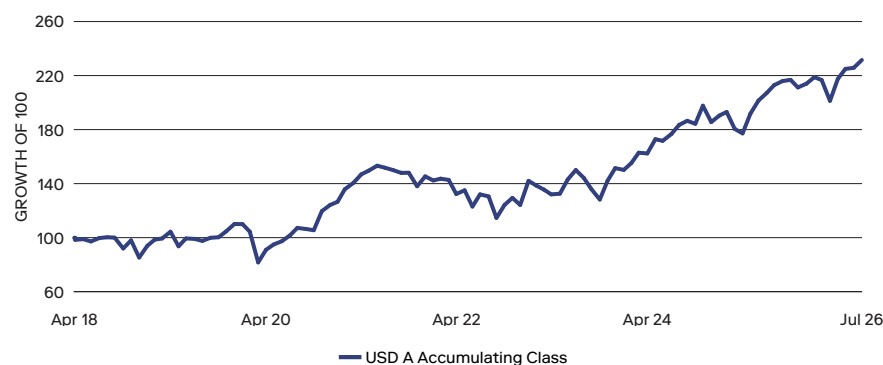
