Dear IRA/Qualified Retirement Plan Shareholder:

If you were born in 1952 or earlier, you may be subject to the Required Minimum Distribution regulations as described in Internal Revenue Code § 401(a)(9). This distribution must be taken no later than December 31, 2026.

If you were born in 1953 or later, you are required to take a Required Minimum Distribution starting the year in which you reach age 73 and each following year.

In the year you attain age 73, the first Required Minimum Distribution may be delayed until April 1st of the following year. For example, if you attain age 73 in 2026, the first distribution may be delayed until April 1st, 2027. If you elect to delay your distribution into 2027, you will also be required to take your 2027 distribution by December 31st, 2027.

If you wish, Neuberger Berman BD LLC. will calculate your distribution for you. The calculation will be based only on your account(s) held with Neuberger Berman and may not satisfy your entire distribution requirement.

Reporting to the Internal Revenue Service:

Your Custodian, UMB Bank n.a., is required to report to the Internal Revenue Service the name and Social Security Number of any IRA owner who is required to take a distribution. This information will be based on 2025 data and will be updated annually. Any distributions you receive in a tax year will be reported to you as income on IRS Form 1099-R. The Form 1099-R will be sent to you by the end of January of the year that follows the year of the distribution.
