Neuberger Berman CLO Income Fund

Performance Highlights

The Neuberger Berman CLO Income Fund (“the Fund”) returned 4.29% (gross) and 4.08% (net) in the second quarter 2026, outperforming its benchmark, the ICE BofA US Dollar 3-Month Deposit Offered Rate Constant Maturity Index (Total Return, USD), return 0.91%. YTD 2026, the Fund generated 2.94% (gross) and 2.53% (net), while the benchmark generated 1.82%.

Market Context

CLO debt spreads tightened meaningfully in April, due to (a) a supportive macro on the heels of the ceasefire agreement announced between the United States and Iran as well as (b) elevated investor demand and limited supply – particularly in the primary market – which led to strong technicals. CLO debt spreads stabilized in May and June as primary market activity meaningfully accelerated in response to tighter CLO liability levels, which at least partially offset continued strong investor demand for CLO debt. As of the end of June, higher quality CLO BBs were pricing in the S+500 basis points area in the primary market, retracing nearly two-thirds of the spread widening that had occurred from February to early March, primarily due to software/AI-related concerns.

With respect to the loan market, software remained the largest source of pressure, and dispersion widened as investors differentiated more sharply by sector, borrower quality and capital structure. We continue to distinguish between larger public software issuers and the more highly levered borrowers common in leveraged loan portfolios, where refinancing paths are less certain.

The CLO BB index¹ gained 5.12% for the quarter. In related credit markets, the loan index² and high yield index³ gained 1.88% and 2.45%, respectively, with CLO BBs outperforming loans and high yield by 3.24% and 2.67%, respectively. Year-to-date, CLO BBs have gained 1.80%, which have outperformed loans by 0.49%, while slightly lagging high yield by -0.09%.

During the quarter, the US CLO primary market had \$24.3bn of new issue volume, bringing year-to-date new issue volume to \$61.8bn (compares to \$80.7bn for the same year-to-date period in 2025). With respect to refinancing and reset activity, the market saw \$86.8bn in total volume during the quarter, bringing year-to-date volume to \$138.3bn (compares to \$133.6bn for the same year-to-date period in 2025). European CLO primary market issuance for the quarter was €14.9bn, bringing year-to-date new issue volume to €30.3bn (compares to €29.7bn for the same year-to-date period in 2025). Primary market issuance in both markets accelerated meaningfully in May and June on the heels of significant tightening in CLO liability levels.

Portfolio Positioning and Performance

The Fund gained 4.29% during the quarter, reflecting gross returns. We believe relative performance versus the broader market during the quarter was partially impacted by our slightly elevated cash balance combined with the Fund's up-in-quality bias which tightened less than lower quality CLO BBs. Year-to-date the Fund has gained 2.94%, reflecting gross returns, with significantly lower volatility versus the broader market for the year-to-date period.

As of June month-end, the yield-to-maturity for the Fund was 9.74% including the forward rate curve. The current yield was 9.16% with an average security price of 99.54, which is reflective of the weighted average coupon of S+558.

With respect to flows, the Fund had \$152mm of net inflows during the quarter, with inflows deployed primarily into a mix of USD and EUR CLO

BBs in both the primary and secondary market. As of June quarter-end, the Fund's AUM was approximately \$1.8bn.

As of the end of June, on a traded basis, the Fund held less than 1% CLO BBBs, 86% CLO BBs, 8% CLO single Bs, 3% in other corporate credit (in the form of loan total return swaps), and 2% in cash & equivalents. The Fund's underlying credit exposure remains balanced with 44% of holdings in USD and 56% in EUR.

Outlook

The trailing 12-month par-weighted U.S. loan market default rate as of June (excluding distressed exchanges) declined to 0.97%, down 47 bps quarter-over-quarter. On an issuer-weighted basis and inclusive of distressed exchanges, the default rate declined to 2.77%, down 53 bps quarter-over-quarter. In Europe, the par-weighted loan default rate as of June (excluding distressed exchanges) was 1.23%, down 19 bps quarter-over-quarter.

Loan market fundamentals remain stable for most issuers, though some lower-rated issuers continue to face industry-specific pressures. We increasingly view the 2028 maturity wall as a refinancing question rather than a near term default concern, and one the market is actively working down. Maturity extension activity reached approximately \$39.7 billion in the second quarter, a record quarterly pace, as sponsors moved to address upcoming maturities well ahead of schedule. This steady clearing of maturities is helping to reduce a key medium-term risk, though we continue to watch for credible refinancing outcomes among weaker, more software exposed borrowers.

In June 2026, the macro backdrop reflected a Fed still firmly on hold but with a more hawkish distribution of outcomes following the latest meeting. While the consensus view remains for policy rates to stay unchanged, several sell-side shops have shifted from cuts to hikes, and the updated Fed dots reinforced a higher-for-longer stance. Our base case is now for the Fed to remain on hold through 2027, though the probability of rate hikes over the next year has become a more meaningful risk, particularly if the Iran conflict remains unresolved and energy prices feed through to inflation expectations. We remain in the "no hike" camp as inflation may have peaked if geopolitical risks continue to moderate, while inflation expectations have so far stayed contained. The latest labor report showed payroll growth cooling sharply to 57,000 in June, with prior months revised lower, while unemployment dipped to 4.2% largely on lower labor force participation. This softer employment backdrop gives the Fed more time to assess the inflation path, though renewed labor resilience and uncomfortable inflation prints remain the key upside risks to rates. The 10-year Treasury ended June at 4.47%, while Brent eased from April highs to the \$106–110 range as Strait of Hormuz disruption risks moderated. Against this backdrop, we remain focused on quality, liquidity, and selective positioning in a higher-for-longer rate environment.

As of June quarter-end, we estimate the CLO BB basis to HY BBs was approximately 340 bps, which is wide of the long-term historical average basis in the low 300s. As a result, we believe CLO BBs may present modestly attractive relative value.
