FUND OBJECTIVE

The fund aims to achieve a target average return of 1% over the benchmark before fees over a market cycle (typically 3 years) by investing primarily in a blend of investment grade rated hard currency (defined as USD, EUR, GBP, JPY, CHF) and local emerging (less developed) market currency denominated debt, issued by sovereigns, quasi-sovereigns, sub-sovereigns and corporate credits in emerging (less developed) market countries that meet the Sustainable Criteria, as detailed in the "Sustainable Investment Criteria" section of the prospectus. There can be no guarantee that the fund will ultimately achieve its investment objective and capital invested is at risk. The fund invests in securities that meet the criteria set out in the Sustainable Exclusion Policy, as detailed in the Prospectus.

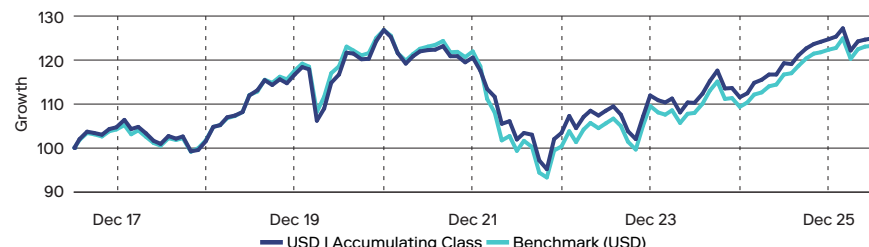
