FUND OBJECTIVE

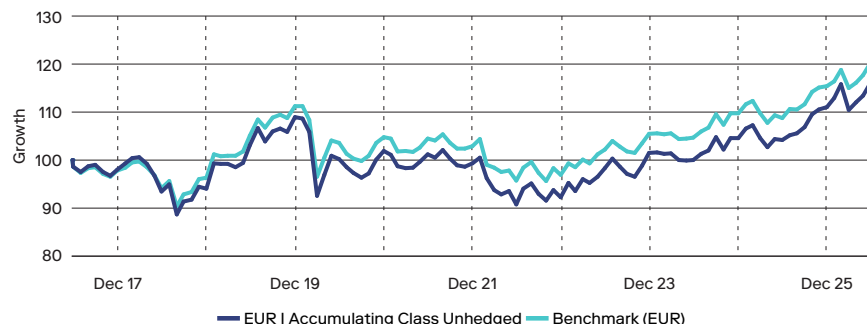
