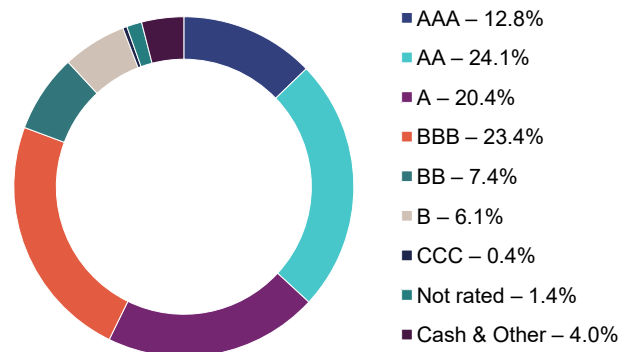

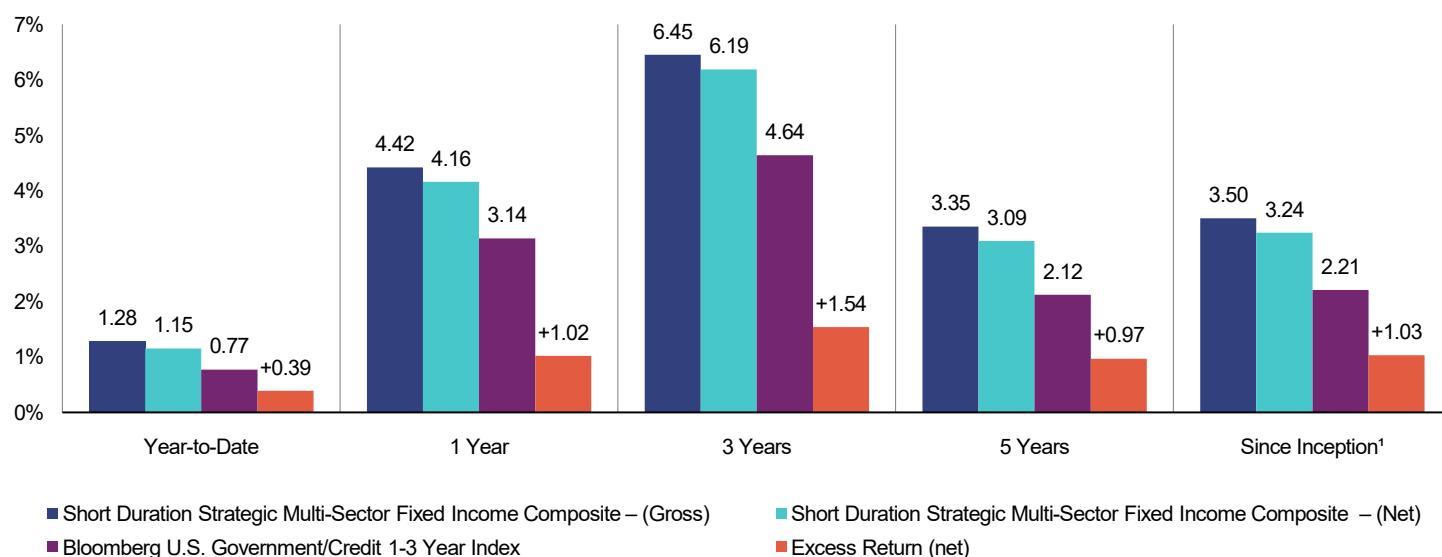

Composite Description

The Short Duration Strategic Multi-Sector Fixed Income composite (the "Composite") represents the performance of all fee-paying Short Duration Strategic Multi-Sector portfolios, with no minimum investment. The strategy is designed for investors who seek an attractive current income from a portfolio that invests predominately in a diversified mix of investment grade short-term fixed and floating rate debt securities, with tactical allocations to non-investment grade securities. The Composite creation date is June 2021 and performance inception date is August 2019. A complete list and description of the NB Composites and performance results is available upon request.

Primary Benchmark Description

The benchmark is the Bloomberg U.S. Government/Credit 1-3 Year Index (the "Index"). The Index includes securities in the Government and Credit Indices with a maturity from 1 up to (but not including) 3 years. The Government Index includes treasuries (i.e., public obligations of the U.S. Treasury that have remaining maturities of more than one year) and agencies (i.e., publicly issued debt of U.S. Government agencies, quasi-federal corporations, and corporate or foreign debt guaranteed by the U.S. Government). The Credit Index includes publicly issued U.S. corporate and foreign debentures and secured notes that meet specified maturity, liquidity, and quality requirements.

Reporting Currency

Valuations are computed and performance is reported in U.S. Dollars. Performance includes reinvestment of dividends and other earnings.

Fees

Composite Gross of Fee returns are the return on investments reduced by any trading expenses incurred during the period. Composite Net of Fee returns are the Gross of Fee returns reduced by model investment advisory fees of 0.25%. Composite Net of Fee returns calculated using model fees deduct 1/12th of the highest tier of the fee schedule from the monthly composite gross returns.

Presented risk measures are calculated using gross-of-fee composite returns.

To the extent that a composite contains fund(s) whereby performance is calculated based on changes in monthly NAV's, net returns reflect miscellaneous fund expenses (admin, legal, etc.) in addition to investment management fees for the portion of composite containing these vehicles.

Fee Schedule

The annual investment advisory fee, generally payable quarterly, is as follows: 0.25% on the first \$100mn; 0.20% on the next \$150mn; 0.15% on the next \$250mn; 0.10% thereafter.

Internal Dispersion

Internal dispersion is calculated using the asset-weighted standard deviation of annual gross returns of those portfolios that were in the Composite for the entire year. Internal dispersion is not calculated if the Composite does not contain at least 6 portfolios for the entire year.

Annualized Standard Deviation

The three-year annualized standard deviation measures the variability of the Composite and the benchmark returns over the preceding 36-month period. The standard deviation is not required for periods prior to 2011.
