

We report payment of a distribution by Neuberger Energy Infrastructure and Income Fund Inc. (NYSE American: NML) (the “Fund”) in the amount of \$0.0584 per share of common stock. This distribution will be payable on March 31, 2026, to common stockholders of record on March 16, 2026. Based on earnings and portfolio activity as of the record date, the distribution is estimated, on a per share basis, to consist of \$0.00 in net investment income, \$0.00 in net realized capital gains and \$0.0584 from return of capital.

The Fund’s ability to pay monthly distributions may be affected by a number of factors, including the amount and stability of income received from its investments, the availability of capital gains, taxes on its taxable income, the level of Fund leverage and the level of other Fund fees and expenses. There is no assurance that the Fund will always be able to pay a distribution of any particular amount, or that a distribution will consist solely of net investment income and/or net realized capital gains.
