

We report payment of a distribution by Neuberger Berman California Municipal Fund Inc. (the “Fund”) in the amount of \$0.0448 per share of common stock. This distribution will be payable on November 15, 2018 to common shareholders of record on October 31, 2018. Based on earnings and portfolio activity as of the record date, the distribution is estimated, on a per share basis, to consist of \$0.0412 in investment income, \$0.00 in realized capital gains and \$0.0036 from return of capital.

The Fund’s ability to pay monthly distributions may be affected by a number of factors, including the stability of income received from its investments, the availability of capital gains, if any, distributions paid on its preferred shares, the level of Fund leverage and the level of Fund expenses. There is no assurance that the Fund will always be able to pay distributions of a particular size, or that a distribution will consist solely of net investment income and/or realized capital gains.

The CUSIP number for the Fund’s common shares is 64123C101.

This notice is not for tax reporting purposes and is being provided only for information purposes to comply with the requirements of Section 19 of the Investment Company Act of 1940, as amended. In early 2019, after definitive information has been provided to the Fund, common shareholders will receive a Form 1099-DIV, which will reflect the actual amount of income dividends, capital gain distributions and return of capital, and the amounts that are taxable in calendar year 2018 and reportable on common shareholders’ 2018 federal and other income tax returns.
