## IMPORTANT 2024 YEAR END TAX INFORMATION

### 2024 Qualified Dividend Income for Individual Shareholders

If you received a Form 1099 DIV, Box 1b shows the portion of the amount in Box 1a that are “Qualified dividends,” which are dividends earned from most domestic corporations and from qualified foreign corporations. These dividends may be eligible for taxation at the same rate as long-term capital gains. Please refer to the instructions in your IRS Form 1040 for information about reporting qualified dividends, including holding period requirements.
