14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ After the close of business on February 23, 2018 certain classes of the Fund underwent a stock split or a reverse stock split of its shares per attached statement #1. After the transaction, each shareholder held the same percentage of shares outstanding of their respective classes of the Fund immediately following the change as such shareholder held immediately prior to the change. This action merely changes the number of shares outstanding of the Fund.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ Each shareholder's aggregate tax basis in the new stock received will equal the aggregate tax basis of the old shares surrendered.
